

## **WE SUPPORT PROTECTING PRIVACY IN TEXAS**

We, the undersigned support legislative efforts to protect the privacy, safety and dignity of Texans in bathrooms, locker rooms, and other intimate facilities in all government buildings, including public schools. Government entities should not allow biological men and boys in girls' bathrooms and changing facilities.

The State of Texas has a duty to protect the privacy, safety, and dignity of all Texans - especially in government buildings. Over the last several years, the Federal government and some local governments and school boards in Texas have pushed for allowing boys and men into girls' bathrooms. We need a state law to have basic, consistent and transparent standards on this important issue across the state.

Texans overwhelmingly oppose attacks on women's privacy and safety as evidenced by Houston voters voting down a dangerous bathroom ordinance that would have allowed men into women's bathrooms, 61% - 39%. In addition, recent polls show that a strong majority of Texas voters agree that boys shouldn't be in bathrooms with girls.

We support efforts by Texas lawmakers to protect privacy in state law.
