Pursuant to the Texas Public Information Act, Section 552.001 *et seq.* of the Texas Government Code, and on behalf of Texas Values and parents in Austin Independent School District (hereinafter Austin I.S.D.) Jennifer Kratky and Matthew Pennies, we request access to and copies of any and all communications, including e-mails, letters, and any other written correspondence between you and/or your staff, and/or any school district offices, and/or school district staff and/or any outside organization during the time period of February 25, 2019- October 31, 2019 pertaining to the following information:

- \* Communications between Planned Parenthood and any of their affiliates pertaining to the cancellation of the purchase of sex education curriculum
- \* Any communications between Austin I.S.D. offices, board members, or staff and Planned Parenthood
- \* Communications between members of the School Health Advisory Council and any member of the Austin Independent School District Board of Trustees
- \* Any communication Austin I.S.D. had with Alberta Health Services
- \* Any communication Austin I.S.D. had with Aids Community Care Montreal (ACCM)
- \* Notes or records of discussion regarding the revised 6<sup>th</sup>-8<sup>th</sup> Human Sexuality curriculum presented for final approval at the October 28, 2019 meeting, Agenda Item 15.2
- \* Notes or records from meetings, including the name of attendees, regarding the passage of Texas Senate Bill 22, passed and signed into law during the 2019 Texas Legislative Session, and the decision to not move forward with the "Get Real" sex education curriculum
- \* Names and position titles of Austin I.S.D. staff members who helped with creating the Human Sexuality Curriculum for grade 3-5 and 6-8
- \* Records of discussion regarding Board Agenda items 15.1 and 15.2 for the October 28, 2019 Board of Trustees meeting
